(v) To provide and encourage drama, classical music, kathak dance, Tandava Nritya, and other allied creative and fine arts and to create facilities for the study and learning of different type of classical music, dramas, dance-dramas and allied fine arts.

(vi) To arrange, encourage, assist and finance the writing, printing and publication of booklet, books and literature for the spread of education and uplift of humanity and to distribute the same among interested persons.

(vi) To promote and encourage the feeling of equality, fraternity, mutual cooperation, national and emotional integration among all sections of the people.

(vii) To establish, run or operate Minority institutions.

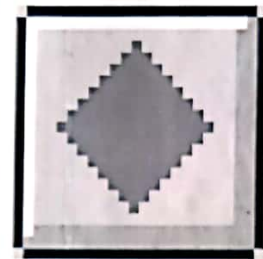
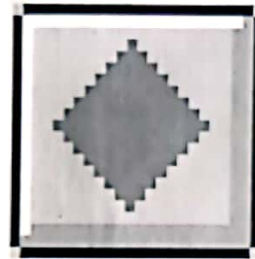

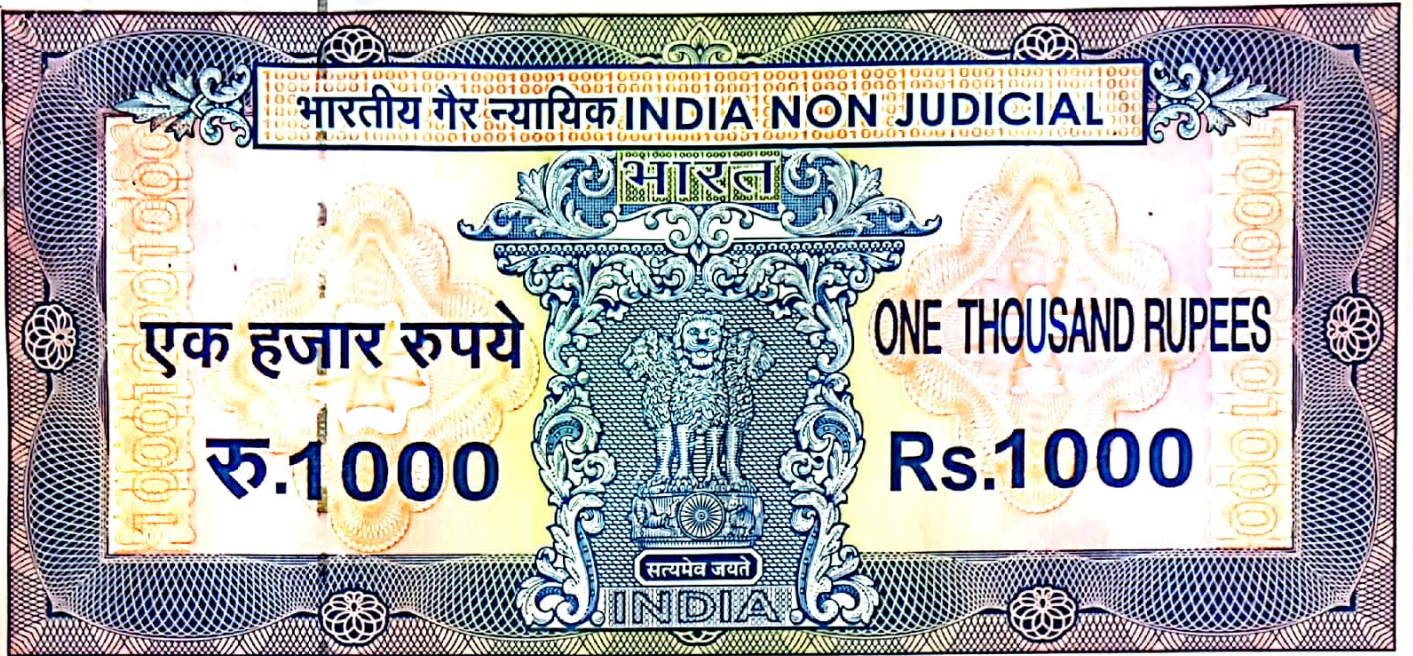

(xiv) To take over the management of or amalgamate with or reconstruct with any other public or charitable institute, or minority institution or project or branch of any such institution on such terms and conditions as the Trustees think fit and manage such institution


(xv) To do all such acts and things as may be conducive to the general well being of the society and social, educational, cultural, technological and economic upliftment of the general masses.

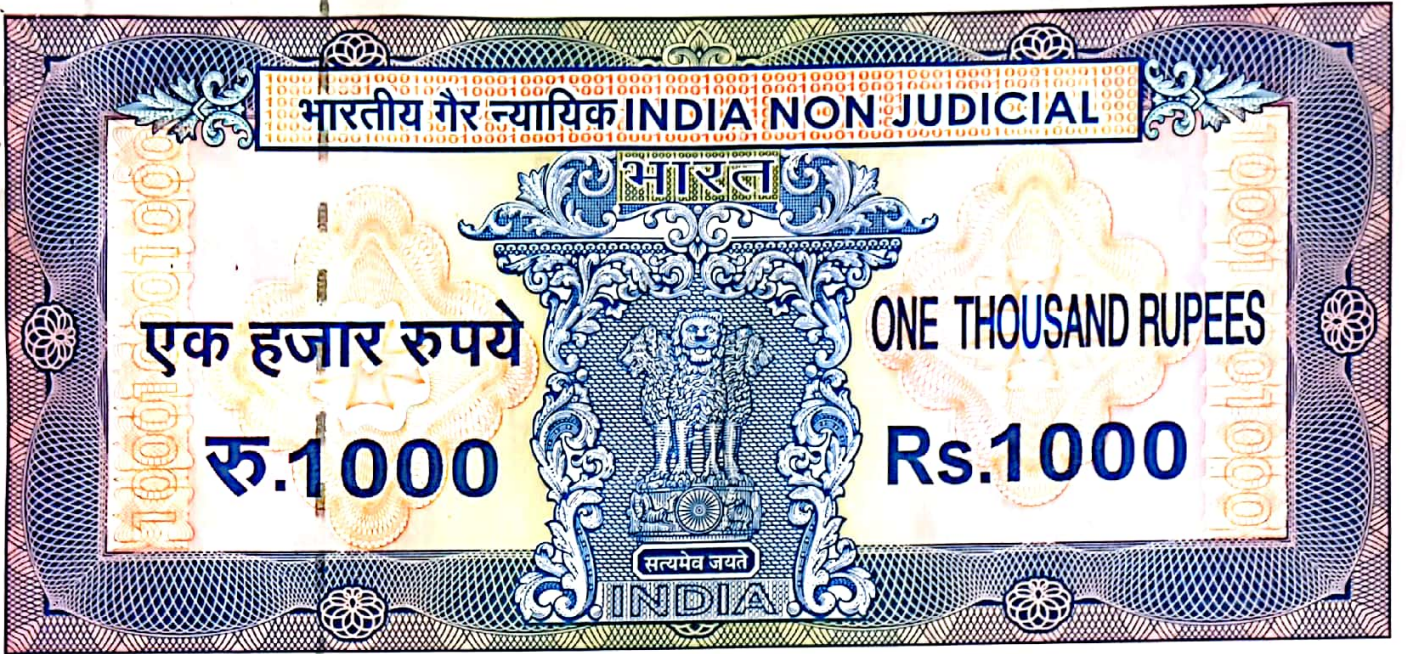

4. BOARD OF TRUSTEES

The management and control of the Trust and Trust properties shall vest in the Board of Trustees which shall comprise of not less than Two and not more Twelve Trustees including the Chairman and Managing Trustees but in case of any dispute, difference of opinion on any issue or interpretation of these presents, the decision of the Managing Trustee shall be final. Further, if the number of the Trustees fall below two for any reason whatsoever, the remaining Trustee, shall not except for the purpose of filling the vacancies, act so long the number of Trustees are below the said minimum.

A. The following shall be on first Board of Trustees, who have consented to act as such :-

1. Shri Deep Narayan Singh Yadav S/o Shri Balbhadra Singh Yadav - Chairman & Managing Trustee
2. Smt. Meera Yadav W/o Shri Deep Narayan Singh Yadav – Executive Trustee

B. Shri Deep Narayan Singh Yadav shall be the Chairman & Managing Trustee and Smt. Meera Yadav shall be the Executive Trustee and they shall hold their office for Lifetime. In case of death or resignation or absence for any reason of any one of them, the other shall be empowered with all powers. Further, in case of death or resignation or absence for any reason of any one of them or both, their heir (s) being their son or daughter(s) or any other Legal heir, will be appointed as a Trustee and will hold the office of Chairman & Managing Trustee as a matter of right in case he or she is willing. Further, there shall be always two Trustees on the board from the family of Shri Deep Narayan Singh Yadav and Smt. Meera Yadav. Furthermore, Shri Deep Narayan Singh Yadav and/or Smt. Meera Yadav reserve the right to nominate and appoint to any other capable person as Trustee during their life time.

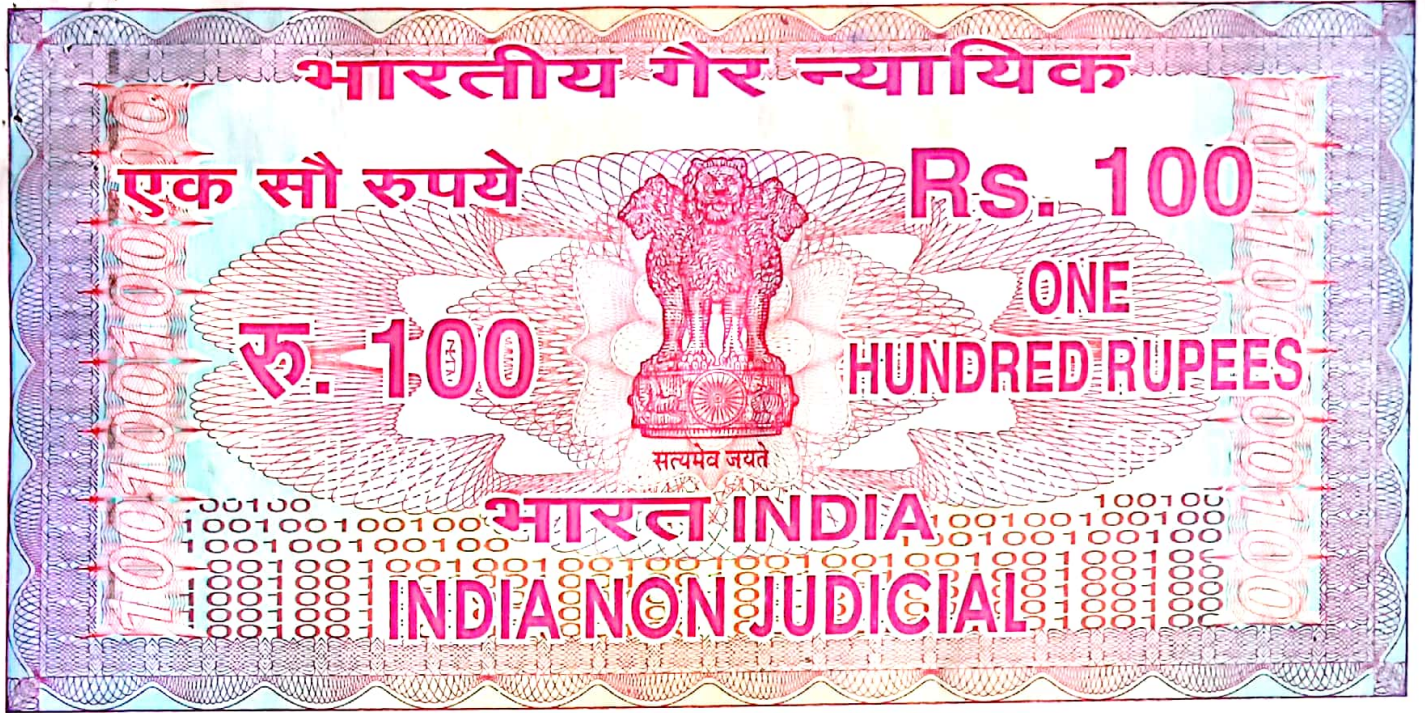
C. Other Trustees, if appointed, shall hold their respective offices for a period of five years but they shall be eligible for re-appointment in the manner as stated hereinafter.

D. In case the office of some Trustees remain vacant, Managing/Chairman Trustee shall ensure that activities of the Trust go on undisturbed and vacancies are filled up at the earliest convenience in the manner as mentioned in these PRESENTS.

E. The Member (s) of Board of Trustees including Chairman and Managing Trustees or any other Trustee if authorized by a Board resolution will be entitled to an honorarium or remuneration for their services rendered to the trust in carrying out the objects and purposes of the trust. They are also entitled to reimburse themselves for all expenses including legal expenses actually incurred or spent by them in connection with the trust or affairs of the trust or borne by them in execution of duties relating thereto.

5. MEMBERS OF THE TRUST

Those who are above the age of 18 years, accept the aims and objects of the Trust, abide by its rules and regulations and pay specific donations as mentioned in these PRESENTS or as may be amended from time to time, may be admitted by the Board of Trustees as the following categories of members of the Trust :-

A. Vishist Member : A Competent person having attained eminence in public Life and willing to guide and advise the Trust may be admitted as 'Vishist' Members of the Trust. Such Member shall hold office for a period of two years and shall be eligible for re-admission.

B. Donor Member : Any person donating a minimum sum of Rs. 1,11,000/- in the Trust fund and fulfilling above mentioned requirements may be admitted as 'Donor' member. This amount of membership can also be paid to the Trust Fund with in a maximum period of two years at rate of Rs. 50,000/- per annum. However, it may be changed, if deemed expedient with the approval of Chairman Trustee.

A. The Trustees may meet from time to time to frame rules for the conduct of the affairs of the Trust. Provided, however that at least one meeting shall be convened in each half of English calendar and the venue of the meeting shall be as decided by the Chairman from time to time.

B. Two trustees, including atleast Chairman & Managing Trustee or Executive Trustee shall form a quorum for a meeting of the trustees.

C. All matters will be decided by the simple majority of the Trustees present in the Meeting unless provided otherwise.

D. Resolutions passed without any meeting of the Trustees but by circulation by post or electronic media thereof and evidenced in writing under the hands of two third of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of trustees.

E. The Trustees shall keep a Minutes Book and Minutes of the entry into office of every new Trustee and of all proceeding of the meeting of the Board of Trustees shall be entered in the Minutes Book and shall be signed by the Chairman and Managing Trustee jointly either at the conclusion thereof or at the next meeting.

10. POWERS TO APPOINT AGENTS & COMMITTEES


The Board of Trustees shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think proper, persons or agents and to appoint Committees or Sub- Committees as they may think proper to function under the authority and control of the Trustees for carrying out the Trust or any institution or Project run by the Trust of THESE PRESENTS or the Management thereof and may within the limit of their own powers invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the objects of the Trust.

11. POWER TO DETERMINE ALL QUESTIONS OF DOUBT OR DIFFICULTY

It shall be lawful for the Board of Trustees to settle and determine all matters of interpretation of THESE PRESENTS AS WELL AS matters of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration, management and execution of the trusts and powers of THESE PRESENTS and any such settlement or determination (although the question involved may not have been actually raised) shall be valid, binding and conclusive and shall not be objected to or re-opened upon any ground whatsoever.

12. POWER TO COMPROMISE AND REFER TO ARBITRATION

The Board of Trustees shall have full powers to settle, compromise or compound, out of Court, all suits, actions and other proceedings and to settle all or other proceedings, differences of demands to arbitration and to adjust the settlement of all accounts relating thereto as fully as they were absolutely entitled to the Trust Fund and without being answerable for the loss occasioned thereby.





13. POWER TO PURCHASE, HIRE, TAKE ON LEASE OR INVEST

The Board of Trustees shall be entitled to purchase or hire or to take or to give on lease a property or properties or invest Trust Fund as mutually decided by them for the purposes of carrying out the objects of the Trust hereby created.

14. POWER TO BORROW

The Trustees may, from time to time, at their discretion for the furtherance of the objects of the Trust of THESE PRESENTS, borrow money(ies) from any Bank, Financial Institution, Company, Trust or Society or Private Party or any other Party to any extent at any time, and for the purpose may authorise the Trustees to borrow money(ies) at such rate of interest and in such form and manner and thereupon the Trustees shall, of their discretion, make all such dispositions of the properties movable or immovable forming part of the Trust Fund or any part thereof and enter into such agreements, assurances, deeds and things in relation thereto as the Trustees may deem proper giving security for such loans and interest.

15. OPENING OF BANK ACCOUNTS

The Board of Trustees may from time to time open and maintain in their names or in the name of Trust or in the name of any Institution run by the Trust any banking account or accounts with any bank or banks as may from time to time be determined by the Trustees and shall forthwith pay or cause to be paid the rents, income, profits, dividends and all other monies forming part of the Trust Fund to the credit of any such account or accounts, such account or accounts shall be operated singly or jointly by the Chairman & Managing Trustee and/ or Executive Trustee or one or more of the Trustee (s) or any agent appointed by the Chairman Trustee and Managing Trustees of THESE PRESENTS.

16. ACCOUNTS AND AUDIT

The Board of Trustees shall get maintained regular & proper books of accounts of the Trust Fund to be closed on 31st March every year and shall get the same duly audited by a firm of Chartered Accountants to be appointed by the Board of Trustees.

17. POWER TO MANAGE, MORTGAGE OR SELL THE IMMOVABLE PROPERTY(IES)

The Chairman and Managing Trustees have full and absolute powers to manage, mortgage, assign, pledge, sell or otherwise convert or deal any movable or immovable property or properties for the time being forming part of the trust Fund for the purpose (s) of carrying out the objects of the Trust hereby created.

18. RECEIPTS OF TRUSTEES

The receipts in writing by the Chairman and/ or any other trustee or trustees or any other person authorized by the Board of Trustees for the time being of THESE PRESENTS for any interest, dividend or income of the Trust fund or for any deeds, papers, writing documents or other monies and effects payable or deliverable to the Trustees shall be sufficient and effectual discharge for the same respectively as in such receipts or receipt shall be expressed or acknowledged to be or to have been received and the persons or person to

Handwritten signature and a circular stamp.

C. Life Member : Any person donating a sum of Rs. 71,000/- to the Trust Fund and fulfilling above mentioned requirements may be admitted as 'Life Member'. This amount of membership shall be payable to the Trust fund with in a maximum period of two years. However, it may be changed, if deemed expedient with the approval of Chairman.

It shall be open to the Board of Trustees to refuse admission to any person as member of the Trust , if in its opinion, he is not considered suitable without giving any reason for refusal. No person can claim to be admitted as Member of the Trust.

6. APPOINTMENT OF NEW TRUSTEES

Subject to the provisions contained in Clause 4 above, the following will apply so far as the appointment of new Trustees is concerned. All Trustees excepting the Life Trustee shall retire at the end of every 5 years but shall be eligible for re-appointment. Such vacancy may be filled in by the Board from amongst the retiring Trustees and/or Vishist, donors and Life Members. If and often as the Trustees of THESE PRESENTS shall die or desire to retire or refuse or become incapable to act in the Trust hereof or shall take the benefit of the Insolvency Law for the time being in force or ceases to be naturalized Indian or if any of Trustees remains absent from three consecutive meetings of the Trustees without leave of absence then and in every such case it shall be lawful for the Chairman/Managing Trustee to fill up the vacancies so caused but in every case the number of Trustees for the time being of THESE PRESENTS **shall not be less than Two or more than Nine** . The Trustees may also appoint additional Trustees or Trustee provided they by the appointment of such additional Trustees or Trustee the maximum number of Trustees fixed above is not exceeded. In case of vacancy, the Donors and Life members shall separately be represented on the Board of Trustees by one of them unanimously elected for the purpose provided the number of each of such categories of members is not less than five.

7.EFFECT OF APPOINTMENT OF NEW TRUSTEES

Up on every such appointment made in pursuance of the last foregoing clauses thereof, the newly appointed Trustees shall have all powers and authorities of a Trustee under THESE PRESENTS.

8. REMOVAL OF TRUSTEE(S)

Two Third of the Trustees shall have power to remove any Trustee(s) except Chairman Trustee and Managing Trustees , if such Trustee(s) is/are misusing his position as a Trustee and reason of such removal has to be recorded in Minutes Book.

9. MEETINGS OF THE BOARD OF TRUSTEES & MINUTES THEROF

The Trustees may from time to time frame rules and regulations for the conduct of the meetings of trustees, however in the absence of such regulations;

whom or in whose favour the same shall be given his or her to their heirs, executors, or administrators shall not be after words in any way obliged or concerned to see to the application of the monies, property and effects therein mentioned and acknowledged to be received or be answerable or accountable for the loss, mis-application or non-application thereof. The Trustees by a resolution may also authorise any bank(s) in India to collect any interest, dividend, fees or income of the TRUST on their behalf.

19. POWER TO AMMEND OR MAKE RULES AND REGULATIONS

The Trustees shall from time to time, be entitled to amend, alter, modify or make rules and regulations or schemes for the purpose of the administration and management of the Trust and any Institution or Project run by the Trust, and all matters of incidental to or concerning the same. Provided that at least three Founder Trustees should be present and all matters will be decided by the majority of Trustees present in the meeting.

20. INDEMNITY TO THE TRUSTEES ETC.

The Trustees for the time being of THESE PRESENTS shall be chargeable only such monies, stocks, funds deposit and securities as they shall actually receive, notwithstanding their signing of any receipt for the name of conformity and shall be answerable or accountable only for their own acts, receipts, neglects, defaults, and not for those of others or of any banker, auctioneer or any other persons with whom or into whose hands any trust monies or securities may be deposited or come in accordance with THESE PRESENTS nor for the deterioration or loss of any stocks, funds, deposits or securities nor for any defects or insufficiency of title nor for any other losses unless the same shall happen through their own. Further, Trustees shall be indemnified/ compensated for any cost or expenses incurred or to be incurred by him or them to justify his/ their acts, deeds or things done to perform his/ their duties or exercising powers.

21. POWER TO REIMBURSE

The Trustees of THESE PRESENTS are entitled to be reimbursed and also to pay and discharge out of the Trust Fund all expenses incurred by them or on their behalf in or about the expenses incurred by them or on their behalf in or about the execution of the Trusts and power of THESE PRESENTS in accordance with the decision of the Board of Trustees.


22. JURISDICTION

- (a) The Trust shall be authorized to function throughout India.
- (b) Any legal disputes, claims or litigation within jurisdiction of the law arise, they will only be considered valid if they are lodged within the precincts of the city of **Jhansi**.


